CENTRAL—WAN CHAI BYPASS AND ISLAND EASTERN CORRIDOR LINK

Amendments under section 7

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to further amend the works and the use originally shown on Plans Nos. 92995/GAZ/1000 to 92995/GAZ/1008 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 92995/GAZ/1000A, 92995/GAZ/1005A, 92995/GAZ/1006A, 92995/GAZ/1007A and 92995/GAZ/1008A ('the Amendment Plans') and described in the first amendment scheme annexed thereto, and subsequently amended as described in the second amendment scheme and shown on the Plan for Creation of Easements and Permanent Rights No. HKM10389 ('the Easements Plan') and further amended by Further Amendment Plans Nos. 92995/GAZ/1000B and 92995/GAZ/1001A ('the Further Amendment Plans') and described in the further amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 4767 published under section 8(2) of the Ordinance on 27 July 2007 and 3 August 2007. The Amendment Plans and the first amendment scheme were referred to in G.N. 8202 published under section 8(2) of the Ordinance on 5 December 2008 and 12 December 2008. The second amendment scheme and the Easements Plan were referred to in G.N. 3775 published under section 8(2) of the Ordinance on 14 June 2019 and 21 June 2019. The Further Amendment Plans and the further amendment scheme were referred to in G.N. 6266 published under section 8(2) of the Ordinance on 11 October 2019 and 18 October 2019. The works and the use as described in the scheme as amended by the first amendment scheme were authorized under section 11(2)(b) of the Ordinance and the notice of authorization was published in G.N. 3010 on 22 May 2009 and 29 May 2009, and which as subsequently amended by the second amendment scheme were authorized under section 11(1) of the Ordinance and the notice of authorization was published in G.N. 5964 on 27 September 2019 and 4 October 2019 and further amended by the further amendment scheme were authorized under 11(1) of the Ordinance and the notice of authorization was published in G.N. 8286 on 27 December 2019 and 3 January 2020.

The proposed further amendments ('the proposed 2020 amendments') are shown on the 2020 Amendment Plans Nos. 92995/GAZ/1000C and 92995/GAZ/1007B ('the 2020 Amendment Plans') and described in the amendment scheme ('the 2020 amendment scheme') annexed thereto. The 2020 Amendment Plans and the 2020 amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed 2020 amendments are as follows:—

- (i) addition of traffic lanes at Island Eastern Corridor westbound and eastbound;
- (ii) construction of noise semi-enclosures on Island Eastern Corridor westbound and eastbound;
- (iii) construction of elevated carriageway on Island Eastern Corridor eastbound;
- (iv) deletion of originally proposed permanent closure and demolition of a section of the existing elevated carriageway on Island Eastern Corridor westbound and replacement by temporary closure and reconstruction of a section of the existing elevated carriageway on Island Eastern Corridor westbound; and
- (v) creation of area for the easements and permanent rights in portions of land in ML 277 RP & Ext., ML 281 & Ext. RP, ML 293 RP & Ext. and IL 7106 s.A & Ext. RP.

The lots where easements and permanent rights are to be created as shown on Plan for Creation of Easements and Permanent Rights No. HKM10653 ('the 2020 Easements Plan') annexed to the 2020 amendment scheme are listed below:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the proposed 2020 amendments in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than the 24th day of November 2020.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
